Bulgarian labour law governs only the provision of employees' labour to an employer. One of the main characteristics of this relationship is that the employer is the economically stronger party, with the employees being in a state of dependence on the employer. What happens if a Bulgarian employee goes on a business trip? any types of work assigned within Bulgaria or abroad in a country outside the EU/EEA and Switzerland, regardless of the type of the assignment. On a standard business trip, the employer temporarily amends the employee's place of work unilaterally. There is no other major change to the terms and conditions of employment. What happens if a contract is not enforceable in Bulgaria? If neither of these requirements are met, the authorities can presume that the contract is in fact an indefinite employment contract, and the employer can be subject to sanctions for circumventing the provisions of Bulgarian labour law.
