Panama's fiscal outlook is expected to worsen as the government's inability to secure congressional backing for more rapid fiscal consolidation underscores the legislative hurdles President Mulino is likely to encounter in advancing his agenda. In late , a massive protest movement erupted over a newly enacted law regularizing the contract of a major copper mine, bringing the economy to a standstill. Why is Panama's fiscal deficit so high? Despite these strengths, fiscal pressures are mounting. Falling revenues and rising expenditures pushed Panama's fiscal deficit to 7.1% of GDP in the first nine months of , the highest on record, including during the pandemic.
