The transaction is the company's first external financing and is understood to be the largest BESS financing in the Nordics to date. Who owns BW ESS? The portfolio of 14 large-scale BESS facilities is the largest in the Nordics. It was inaugurated by Sweden's Minister for Climate and the Environment, Romina Pourmokhtari, in October last year. The assets are majority owned by BW ESS and were jointly delivered by BW ESS and Ingrid Capacity. Did BW ESS & Ingrid capacity get a green loan?
