When will electronic transport documents become mandatory in Serbia? The Serbian government has published a draft bill that would introduce mandatory electronic transport documents or electronic delivery notes, to take effect from January . Where can I find current business opportunities at ESS? Current and forthcoming business opportunities at ESS are posted in the Procurement Listings. Completed tenders are published quarterly in the Contract Award Notices. All procurement follows the European Spallation Source ERIC Procurement Rules, which align with the EU treaty principles of transparency, non-discrimination and competition. What are the new e-invoicing rules in Serbia? The Electronic Invoicing Act in Serbia is being updated. The new rules will come into force on 1 January . They will affect the e-invoicing system. VAT on electronic invoices must be paid within 12 days. File a new import VAT return. No longer have to report retail invoices.
