Public sector entities are also subject to various government- mandated policies with respect to their purchasing of goods and services<sup>1</sup>. How important is e-procurement in Canada?This represents a 5% increase from the previous year, clearly reflecting the growing importance of procurement across various sectors such as infrastructure, technology, defense, healthcare, and education. Over 85% of government entities in Canada now rely on e-procurement platforms. What is a procurement data dictionary?The Procurement Data Dictionary offers a description of each data field contained in the SOSA CSV file. The XML file is meant to be used as a guide for understanding the various data elements. It is updated on an "as needed" frequency to reflect any changes to data elements. What is a procurement engagement session?Engagement sessions give suppliers the "context" for the upcoming procurement, offering an opportunity to gain advance understanding of requirements, to provide input into the process, to ask questions, to seek clarification, to meet government officials involved in the process and to see who potential competitors may be. Can procurement entities add additional grounds for exclusion?Procuring entities are not prohibited from adding additional grounds for exclusion, provided that this process and the identified grounds for exclusion remain in compliance with the trade agreements.
