How much money will Greece get from the Recovery & Resilience facility? The competition is the first of several calls for tenders scheduled for this year. The maiden tender will be open until July 10 and will seek to award some EUR 200 million (USD 215m) in funding from Greece's Recovery and Resilience Facility. Proposals will be reviewed by August 9. How many Bess auctions will be held in ? The battery storage facilities are planned to be connected to the country's transmission grid.
