How much does government procurement cost in New Zealand? New Zealand's government procurement, valued at roughly \$40 billion NZD annually, opens doors for businesses of all sizes. The centralized platform, Government Electronic Tenders Service (GETS), publishes opportunities and categorizes them as low-value (under \$50,000 NZD), medium-value (\$50,000-\$250,000 NZD), and high-value (over \$250,000 NZD). Should a business purchase a solar system?
