Why does Zimbabwe lack private sector investment in the mini-grid market? A number of barriers have restrained the development of the commercial mini-grid market in Zimbabwe. The country is endowed with uncertainty and has low investor confidence due to its historic political and economic climate. It is therefore lacking private sector investment in the mini-grid market. How much does a mini-grid cost in Zimbabwe? In summary, this report estimates an annual mini-grid market size of USD \$54.4 million in Zimbabwe, based on an average mini-grid tariff of USD \$0.28/kWh, and average household demand per day of 2.2kWh. This implies per capita annual electricity expenditure of \$49.94 within the population best served by mini-grids. Based on an estimated cost- Are mini-grids regulated in Zimbabwe? All existing mini-grids in Zimbabwe are below the threshold of 100kW. This has mainly been due to avoiding the burden of regulatory compliance and to reduce cost by avoiding to pay a licence fee. This may leave uncertainty as to how the licencing and regulating process will work in practice, specifically relating to mini-grids. How many people will be best served by mini-grid solutions in Zimbabwe? (Carbon Trust analysis) Our analysis estimates that 1.1 million people (6% of the non-electrified population) will be best served by mini-grid solutions in Zimbabwe. How much does Zimbabwe spend on government procurement? Zimbabwe's government procurement spending fluctuates, but remains significant. In , it peaked at US\$7.2 billion, representing 10.5% of the country's GDP. Construction materials, medical supplies, and foodstuffs are major purchases. However, economic challenges saw spending dip to US\$6.0 billion in , accounting for 8.2% of GDP.
