How does procurement work in Brazil? Brazil has very formalistic and regulated procurement laws and government purchasing methods. The vast majority of public tenders are limited to companies registered in Brazil. However, in some cases, foreign companies can participate in the process as a party to consortia. What is Brazil's new procurement law? Like its predecessor, the new Procurement Law contains very strict procurement rules that offer little room to public officials to change the procurement process. Brazil's new Procurement Law came into force on 1 April. Does Brazil have a public procurement Tribunal? No. In Brazil we do not have specialized Courts or tribunals with power to deal with public procurement issues. Disputes regarding public procurement legislation take place in judicial Courts or in arbitration proceedings depending on the dispute resolution clause. What is the Brazilian Public Procurement Law (PPL)? Law No 14,333/ was enacted in early and substituted Law No 8,666/, the prior public procurement law, that shall only remain in force governing contracts originally executed under its validity. From now on, we are referring to Law No 14,333/ as the Brazilian Public Procurement Law (PPL). Is public procurement a legal challenge in Brazil? Challenges involving public procurement matters are common in Brazil. Pursuant to the Brazilian Federal Constitution, the law shall not exclude any injury or threat to a right from the analysis of Judicial Courts (Article 5, XXXV). How much money does the Brazilian Government procure in ? In , the Brazilian government procured over US\$500 billion in goods and services through tenders. Bidding for tenders in Brazil is extremely lucrative for companies of all sizes. Brazil tendering authorities release contracts for most of the products and services procured by them benefitting small, medium and large enterprises. Brazil Price, payment terms, and financing can be a significant factor in winning a government contract.
