When will the electronic public procurement portal be available in Croatia? As of 1 January, the new website of The Electronic Public Procurement Portal of the Republic of Croatia is also in use. Is electronic procurement mandatory in Croatia? The electronic submission of tenders has been mandatory in Croatia since 1 January. Currently Croatia has one centralised electronic public procurement system operated by the National Gazette - the Electronic Public Procurement Classifieds of the Republic of Croatia (EOJN). Private entities are not allowed to operate e-procurement systems. Can foreign companies participate in Croatian public tenders? In accordance with this directive, since the end of, all tenders in Croatia are submitted electronically, complying with the public procurement legislation of the Republic of Croatia including its last amendment. Foreign companies considering participation in Croatian public tenders are welcome to apply. Note: The amounts of fees for the initiation of appeal procedures, in which the amounts are stated in euros, are applied as of January 1, which is the date of introducing the euro as the official currency in the Republic of Croatia.
