



How is energy storage handled in Sweden? However, the usage of energy storage, for example by using a battery, is not explicitly dealt with in the Swedish Electricity Act. As such, there are no explicit provisions for how energy storage is to be handled from a grid perspective. What regulations apply to electricity markets in Sweden? In addition to the Electricity Market Regulation and the Electricity Market Directive, the organisation of electricity markets is regulated by a number of European Commission regulations, which are directly applicable in Sweden. 9 Capacity calculation region: the geographical area in which coordinated capacity calculation is applied. Does Sweden have a retail electricity market? The Swedish retail electricity market has been open to competition since 2011, and prices are set by market participants. There are approximately 5.6 million electricity customers in Sweden, of which approximately 4.7 million are household customers<sup>83</sup>. How much did electricity cost in Sweden in 2011? In 2011, electricity prices were significantly lower than in 2010 in all Swedish bidding zones. On average, the system price was 64 €/MWh in 2011, which was a decrease of 55 per cent compared with the previous year's prices. In the four Swedish bidding zones SE1, SE2, SE3 and SE4, the average prices were between 46 and 74 €/MWh. Who regulates natural gas supply in Sweden? The Swedish Energy Agency is the regulatory authority under the Security of Natural Gas Supply Act (2002:273). In accordance with the requirements of the Natural Gas Supply Regulation<sup>126</sup>, a national preventive action plan and a national crisis plan for security of natural gas supply were published in 2011.<sup>127</sup> How do aggregation services work in Sweden? Before an aggregation service provider starts to provide such services at an electricity user's withdrawal point, it shall notify the grid operator with which the electricity user has a contract.
