The ESS uses certificate conversion factors to calculate how many ESCs are created for the amount of energy that is saved from an activity. The scheme is designed so that a savings of 1MWh equates to 1 ESC. Are ESS incentives bringing forward energy-efficient lighting retrofit projects? A study commissioned by the NSW Government in found that ESS incentives have brought forward lighting retrofit projects 7 to 10 years earlier than they would otherwise have occurred<sup>1</sup>.
