Every Argentinian employer is obliged to offer employees mandatory or statutory benefits for their service. These mandatory benefits refer to all those aspects of employee protection stipulated by Argentine labor law. They include: Argentinian laws stipulate that employers commit 25% of the employee's monthly salary to social security. How much do employees get paid in Argentina? All employees in Argentina are entitled to a 13-month salary, which is to be paid in two instalments (on June 30 and December 18). Each salary installment should be equal to 50% of the employee's highest monthly wage for the past six months. What are mandatory benefits in Argentina? Mandatory benefits are the ones that are required by Argentine law for all workers based in Argentina. Keep in mind that the benefits required by the government of Argentina are statutory minimums, and employers can always offer more than these mandatory benefits.
