"The construction of energy storage facilities is essential for the stabilization of the power system and more efficient use of the growing production of energy from renewable sources. The aid will be provided in the form of subsidies of up to 45% of eligible costs which may be spent by 30 June at the latest. Proposals may be submitted until 14 March .
