In essence, if market prices are below a project's bid price, the project receives the difference as a subsidy, whereas if Greece awards 189 MW of battery storage in third The average subsidy price in the third auction exercise came at EUR52589.16/MW/year. The lowest successful bid stood at EUR43927/MW/year, concerning a 25 MW/100 MWh project in the Western Macedonia region.
