Will EPC contracts provide for the handover of a solar facility? EPC Contracts will not provide for the handover of the solar facility to the Project Company, and the PPA will not become effective until all commissioning and reliability trialling has been successfully completed. Should you choose an EPC contract for a solar project?
